Drinking Water Quality and Compliance Annual Notice to Consumers <u>Town of Elrose</u>

Introduction

The Water Security Agency requires that at least once each year waterworks owners provide notification to consumers of the quality of water produced and supplied as well as information on the performance of the waterworks in submitting samples as required by the Permit to Operate a waterworks. The following is a summary of the **Town of Elrose** water quality and sample submission compliance record for the 2018 time period. This report was completed on January 21, 2019. Readers should refer to Water Security Agency's Municipal Drinking Water Quality Monitoring Guidelines, June 2015, EPB 502 for more information on minimum sample submission requirements and the meaning of type of sample. Permit requirements for a specific waterworks may require more sampling than outlined in the department's monitoring guidelines. The presence of these substances will affect the acceptance of water by consumers and/or interfere with the practice of supplying good quality water. Compliance with drinking water aesthetic objectives is not mandatory as these objectives are in the range where they do not constitute a health hazard. The aesthetic objectives for several parameters (including hardness as CaCO3, magnesium, sodium and total dissolved solids) consider regional differences in drinking water sources and quality.

Total 2018 Operating Revenue: \$428,549

The 2018 Operating Expenditures \$274,256 Plus Debt Repayment \$148,521

Total 201 Expenditures \$422,777

\$5,772

Comparison of waterworks revenue to expenditures:

Operating: \$428,549 (revenue) / \$422777 (expenditures and debt repayment) = 1:1.02

For the year 2018, 100% of the operating expenditures were covered by water revenues.
