A BYLAW TO AMEND BYLAW #247 – 1996 TO REGULATE AND LICENSE ANY BUSINESS, TRADE OR CALLING.

The Council of the Town of Elrose, in the province of Saskatchewan, hereby enacts as follows:

Section 8 (1) For a Hairdresser, Hairstylist, or Barber shall be amended by deleting the amount of \$25.00 and inserting the amount of \$50.00 per year.

BYLAW 247 - 1996

A BYLAW TO REGULATE AND LICENCE ANY BUSINESS, TRADE OR CALLING NOT ASSESSABLE FOR THE PURPOSES OF BUSINESS TAXATION IN RESPECT TO THEIR BUSINESS, TRADE OR CALLING.

The Council of the Town of Elrose in the Province of Saskatchewan hereby enacts as follows:

- 1. No persons shall carry on any business, trade or calling within the municipality unless they have in their possession a valid and subsisting licence for the purpose issued in accordance with the provisions of this by
- 2. The Administrator of the municipality is hereby authorized to issue a license to any person carrying on a business, trade or calling in the municipality:
- a) Who is not assessable by the municipality for the purposes of business taxation in respect to that business, trade or calling: and
- b) Who makes application for such license stating specifically the nature of their business in the municipality: and
- c) Who tenders with their application the proper license. fee as provided for in section 8.
- 3. Every yearly license issued under the authority of this bylaw unless suspended or revoked shall expire on the thirty-first day of December of the year of issue.
- 4. Every daily license issued under the authority of this bylaw unless suspended or revoked shall expire at the hour of 11:59 P.M. of the day so specified.
- 5. Every license issued shall specifically state the kinds of services, goods or merchandise which the licensee is authorized to provide or offer for sale or take orders for as the case may be and whether in the case of goods or merchandise they may offer the same for sale by retail or by public auction or both. Such license shall also state the restrictions as set forth in section 6 hereof.
- 6. No person to whom a license has been granted under this bylaw shall offer for sale services, goods or merchandise or solicit orders for future delivery of goods or merchandise within the town:
- a) other than a kind of kinds described in the license: or
- b) by any method except as stated in the license.
- 7. Every person licensed under this bylaw shall, at all reasonable times, upon request of the Administrator, the bylaw enforcement officer or license inspector, or any peace officer, produce such license for inspection purposes.

8. The fee payable for a license under this bylaw shall be as follows:

1. For a Hairdresser, Hairstylist, or Barber Per Year

\$25.00

For all other trades or sales persons carrying on business, offers to provide service for a price, offers goods or merchandise for sale

\$55.00

Per Year

\$50.00

All non residents including sales persons, businesses, or tradesmen.

Per Day

\$50.00

Per Year \$100.00

9. Local based non profit organizations are exempted from any or all provisions of this bylaw.

10. Any person who contravenes the provisions of this bylaw is guilty of an offense and upon conviction, shall be liable to the penalties as provided for in the general penalty bylaw of the municipality.

11. Bylaw #213 - 1985 is hereby repealed.
