

**TOWN OF ELROSE**

**BYLAW # 2025-02**

A BYLAW TO FIX THE RATES TO BE CHARGED FOR THE COLLECTION, REMOVAL AND DISPOSAL OF WASTE & RECYCLE OR REFUSE BY A THIRD PARTY CONTRACTOR ON BEHALF OF THE TOWN OF ELROSE, AND TO PROVIDE FOR TRANSFERRING ANY UNPAID ACCOUNTS TO THE TAX ROLL.

The Council of the Town of Elrose in the Province of Saskatchewan enacts as follows:


1. In this bylaw including this section:
  - (a) "municipality" means the Town of Elrose;
  - (b) 'clerk' means the clerk/administrator of the municipality.
2. Persons and or businesses who own or occupy premises being serviced with the collection, removal or disposal of waste and recycle or other refuse shall pay for such services, a service charge in accordance with those set out in Appendix 'A'.
3. Monthly accounts for collection, removal or disposal of waste and recycle or other refuse shall be rendered on the next utility billing for bins located at a resident or business within the Town of Elrose Limits.
4. Any sum payable to the Urban Municipality for the collection, removal or disposal of waste and recycle and Transfer Station Fees that remains unpaid on December 31 of the fiscal year in which the sum became payable is to be added to, and thereby forms part of the taxes on the land and buildings in respect of which the collection, removal or disposal is done.
5. Bylaw #2023-08 are hereby repealed.

### APPENDIX "A" OF BYLAW NO. 2025-02

Appendix "A" respecting Rates for Waste and Recycle Collection removal by a third-party contractor operating known as Triways on behalf of the Town of Elrose.

#### Monthly Rates

The minimum monthly rate will be	\$ 25.00
Residential and Commercial "Carts" (includes one waste cart and one recycle cart)	\$ 25.00
Each additional "Cart" shall be an additional	\$ 12.50

Initial delivery of 3 yard, 4 yards, or 6 yard bins shall be billed to ratepayer as per Triway Disposal Services Fees.

Each bin shall be billed to Ratepayers, as per Triways Disposal Services Invoice, on their Utility Bills on a monthly basis.

- 3 yard bins emptied bi-weekly
- 3 yard bins emptied monthly
- 4 yard bins emptied bi-weekly
- 4 yard bins emptied monthly
- 6 yard bins emptied bi-weekly
- 6 yard bins emptied monthly

Locks for 3 yard, 4 yard and 6 yards bins with two keys will be charged a one-time fee of \$35.00.

Carts must be placed 10 feet from center of the street. Triways has the right to refuse pickup if not 10 feet from the center of the street.

#### Short Term Residential "Rent Me" Bins 6 Yard

Residential Ratepayers may rent a short-term bin for up to 30 calendar days at one civic address that must be placed on the Ratepayer's property, not Town property. If the Ratepayer wants to extend the rental for more than 30 calendar days, they must have authorized written approval from Elrose Town Council.

#### Delivery of New Carts

- a) Houses that require replacement waste and recycle carts will be charged \$50.00 to cover the cost of delivery.
- b) New buildings, previously for which no cart service was ever initiated, will not be charged for delivery and administration changes.

#### Removal of Existing Carts

- a) Houses with existing Waste/Recycle Carts that no longer require the service will be charged \$100.00 for removal and administration fees.

#### Wear and Tear

- a) Normal wear and tear are covered by Triways, and pictures and description need to be emailed to [carts@triwaysdisposal.com](mailto:carts@triwaysdisposal.com) and a copy emailed to the [townofelrose@sasktel.net](mailto:townofelrose@sasktel.net)
- b) Carts that have been abused or neglected by other means than normal wear and tear will be charged to the Town of Elrose and then billed to the Homeowner.

## APPENDIX "B" OF BYLAW NO. 2025 - 02

### Triways Waste and Recycle Cart Pick Up – April to October

Each calendar year from APRIL TO OCTOBER Waste and Recycle Carts will be ONE SIDE pickup, map below shows the Triways Disposal Services route. Waste and recycle carts must be placed on the **RIGHT-HAND** side in the directions of travel, as shown on map for pick up. Triways Disposal Service has the right to refuse pickup if Carts are not placed 10 feet from center of the street.

During this period there will be no pick up on 1<sup>st</sup> Street West and 2<sup>nd</sup> Street West or 1<sup>st</sup> Street East and 2<sup>nd</sup> Street East, Carts must be moved to the Avenue (or closest place on route) for pick up.

Main Street Alley pick up will be year round.
