Animal Control Bylaw

We have adopted a new bylaw for the regulation and control of animals. The bylaw can be viewed on the Town of Elrose – Town Office Facebook page, at the Town Office (at a cost of \$5.00 for copies) or at your request we can email a copy to you.

2019 Business Licenses

Bylaw #247-1996 states that “No persons shall carry on any business, trade or calling within the municipality unless they have in their possession a valid and subsisting license.” This also includes all home based businesses. License fees shall be:

Daily	\$25.00/day
Elrose residents	\$50.00/year
Non-residents	\$100.00/year

2019 Pet Licenses

Bylaw #01-2019 states that:Every person residing within the Town of Elrose, being the owner of a dog or cat three months old or older shall obtain a license for the dog or cat from the Town Office for the purpose of registering the dog or cat.

License Fees shall become due on January 1st of each year or at any time during the year immediately upon a person becoming an owner of a dog or cat, and failure to do so shall constitute an offence under this Bylaw.

License fees shall be:

For each neutered male.....	\$10.00
Unneutered male.....	\$25.00
For each spayed female.....	\$10.00
Unspayed female.....	\$25.00

- **Snow Removal & Yard Maintenance Bylaws** - two new bylaws:

Bylaw No. 2018-1: To control the Removal of Snow, Ice and other Obstructions from Private Property.

Bylaw No. 2018-4: To Control the Maintenance of Yards, including the Cutting of Grass on Private Property and Boulevards.
