2019 Business Licenses

Bylaw #247-1996 states that "No persons shall carry on any business, trade or calling within the municipality unless they have in their possession a valid and subsisting license." This also includes all home based businesses. License fees shall be:

Elrose residents \$50.00/year Non-residents \$100.00/year

^{**}If you see any out of town business working in Town please inquire with them if they have purchased their Business License from the Town Office. Thank you.**

2019 Pet Licenses

Bylaw #11 – 2007 states that "every person residing within the Town of Elrose and being the owner of a dog or cat within the Town shall cause each such dog or cat to be registered with the Town Office and shall obtain a license for the dog or cat from the Town Office.....License Fees shall become due on January 1st of each year or at any time during the year immediately upon a person becoming an owner of a dog or cat, and failure to do so shall constitute an offence under this Bylaw. License fees shall be:

| For each neutered male | .\$10.00 |
|------------------------|----------|
| Unneutered male | \$25.00 |
| For each spayed female | \$10.00 |
| Unspayed female | .\$25.00 |

Just a reminder:

- Outstanding Utility Bills (not including December) and invoices that remained unpaid as of December 31, 2018 will be added to your Property Taxes. A 10% penalty will be levied on all unpaid Property Taxes on January 1, 2019.
- Snow Removal As per Bylaw 1-2018, snow cannot be shoveled/blown or dumped into the streets, therefore, for both residents and businesses any excess snow can be taken to the north side of the rodeo grounds or to the compost site. In addition, snow must be cleared within 24 hours of the end of the snowfall.
- **eTransfer Payments** We now have the ability to accept eTransfers for payment of Utilities, Taxes and fees. eTranfers can be sent to townofelrose@sasktel.net. Please note that *Utility* payment receipts will not be mailed out, if you require a receipt please contact the Town Office.
