Waste Transfer Station – Attendant Position

The Town of Elrose and the R.M. of Monet are currently seeking to hire a Part time/Casual Waste Transfer Station Attendant. Duties include: monitoring all incoming waste, invoicing and ensuring the safe and efficient operation of the site.

Speed Limit Change – 30km is now in effect

The 30km speed limit within Town of Elrose municipal boundaries is now in effect. This Council decision was made due to numerous concerns regarding speeding causing unsafe and even dangerous situations. We want to ensure that all residents, especially our children, are safe when out and about.

2020 Property Tax

Council has made the following changes regarding the **2020 Property Taxes** due to the CoVid-19 pandemic.

- The **2020 Discount rate periods** will be extended to:
 - 5% Discount from January 1, 2020 to September 30, 2020
 - 3% Discount from October 1, 2020 to December 31, 2020
- There will be **NO interest penalty** levied 2020 Property Taxes, if there is a balance owing as of December 31, 2020.

Just a reminder:

- The **TOWN OFFICE** and the **MAINTENANCE SHOP** continue to be closed to walk in traffic but with services continuing as usual. The **Waste Transfer Station** is OPEN and operating hours remain the same.

Social Distancing Payment Options are as follows:

1. Place your payment in an envelope with your name, payment purpose and account number and place it in the mail slot located beside the front door of the Town Office. Receipts will be mailed.
- **If making a payment of cash, please put it thru the mail slot during business hours. This will ensure that we pick it up right away**
2. Make your payment by using online banking services at your financial institution.
3. Mail a cheque to Town of Elrose, Box 458, Elrose, SK S0L 0Z0. (Please enclose payment & account information with the cheque.)

- **Waste Transfer Station Fee Schedule Change – Effective June 1, 2020** - The Waste Transfer Station Bylaw has been amended with changes being made to Appendix B (known as the Fee Schedule) to include fees for Construction and/or Renovation Materials and Shingles. Please find a full version of Bylaw 2020-01 on our website (www.elrose.ca) under Town of Elrose – Government Administration - Bylaws.
- Please remember when using disinfectant wipes they need to be disposed of in the garbage, not flushed down toilets. Wipes, including baby wipes, napkins, paper towels and tissues can clog up the sewer lines and cause back ups. Thank you.
